This is to inform you that SEBI in order to aware the shareholders/investors with dispute resolution mechanism against a listed company or its Registrar and Share Transfer Agent (RTA) on delay or default in processing the investors service(s) request who hold shares in physical form, have issued a direction vide Circular No. SEBI/HO/OIAE/2023/03394 dated 27-Jan-2023 pursuant to its Circular No. SEBI/HO/MIRSD/MIRSD\_RTAMB/P/CIR/2022/76 dated 30-May-2022, on Standard Operating Procedures (SOP) for dispute resolution under the Stock Exchange arbitration mechanism for disputes between a Listed Company and/or Registrars to an Issue and Share Transfer Agents (RTAs) and its Shareholder(s)/Investor(s).
