**Sub: Intimation of due date of transfer of dividend and corresponding shares to the Investor Education and Protection Fund for the year 2013-2014**

Pursuant to provision of sub-section (6) of Section 124 of the Companies Act, 2013 (the "Act") and Rule 18(3) of the Investor Education and Protection Fund Authority (Accounting, Auditing, Transfer and Refund) Rules, 2016 and subsequent amendment/modifications thereto ("the Rules"), all unclaimed dividends are required to be transferred by the Company to the IEPF Authority established by Central Government, after expiry of seven consecutive years shall be transferred by the Company on 6<sup>th</sup> October, 2021 in the name of 'Investor Education and Protection Fund'. Please note that no claim shall lie against the Company in respect of the shares transferred to IEPF.

In case you do not claim the above mentioned dividend on or before 29<sup>th</sup> September, 2021, the said shares held in your name shall be transferred from your name to the IEPF. Thereafter, shares may be claimed from the IEPF Authority.

In the event of transfer of shares held by you and the unclaimed dividends to IEPF, you are entitled to claim the same from IEPF by submitting an online application in the prescribed Form IEPF-5 available on the website [www.iepf.gov.in](http://www.iepf.gov.in) and sending a physical copy of the same duly signed to the Company along with requisite documents in the Form IEPF-5.
