Per: Bidisha Banerjee, Member (Judicial):

- 1. This Court is convened through hybrid mode.
- 2. - 6. By an order dated 17th April, 2023in Company Application (CAA) No. 18/KB/2023 (at pg. 340 to 349, Volume of the Petition), this Tribunal passed the following directions with regard to meetings of shareholders and creditors under Section 230(1) of the Act:
- (a) Meetings of Equity Shareholders: Meeting of the Equity Shareholders of the Petitioner Company to be held on 25th May, 2023 at 11.00 A.M. and Ms.Urmila Chakraborty was appointed as Chairperson and Mr. Hansraj Jaria was appointed as Scrutinizer of the said meeting.
- (b) Meetings of Sundry Creditors and Unsecured Creditors Dispensed: Meetings of the Secured Creditors and Unsecured Creditors of the Petitioner as dispensed with as there are no

Secured Creditors and Unsecured Creditors.

(c) Ms. Urmila Chakraborty Advocate appointed as Chairperson has filed her report on 10th June 2023(Annexure K at Pages 350-373 Volume III of the Petition). The Learned Counsel for the Petitioners further submits that in compliance with Section 230(5) of the Companies Act, 2013 and the said order dated 17th April, 2023 made in Company Application (CAA) No. 90/KB/2023, notice along with all accompanying documents has already been served on the undermentioned Statutory /Sectoral Authorities, , including the Regional Director, Eastern Region, Ministry of Corporate Affairs, Kolkata; Registrar of Companies with whom the Petitioners are registered; and Official Liquidator, High Court, Calcutta, and to the Income Tax Department having jurisdiction over the Petitioners. The Income Tax Department has already given their **No objection** vide DIN and letter no. ITBA/COM/F/17/2023-24/1053655820(1) dated 12th June 2023 attached as Annexure T, Pages 424-425, Volume III in the Petition.

- 7. Upon perusing the records and documents in the instant proceedings and considering the submissions made on behalf of the Petitioners, we admit the instant petition and fix the next date of hearing on 18th August 2023.
- 8. At least 10 (ten) clear days before the said date fixed for hearing, the Petitioners shall cause notice of hearing to be advertised in the "BUSINESS STANDARD" in English and "AAJKAL" in Bengali as per Rule 16(1) of the Companies (Compromises, Arrangements, and Amalgamations) Rules, 2016 ("CAA Rules").



- 9. Another notice pursuant to Section 230(5) of the Companies Act 2013 along with accompanying documents, including the copies of the aforesaid Scheme and statement under the provisions of the Companies Act, 2013 as sent earlier shall be served again on Regional Director, ER (MCA) Kolkata, Registrar of Companies West Bengal, Kolkata and The Official Liquidator, High Court, Kolkata by sending the same to them either by hand delivery through special messenger, within 7 days from the date of receiving this order or by speed post and also by e-mail. Since the learned counsel has mentioned that the no objection from Income Tax authorities as mentioned in para 6(c) hereinabove has already been received, no further service is required in their case. Similarly as mentioned in Paragraph 4 hereinabove, stock exchanges, namely National Stock Exchange, Bombay Stock Exchange and Calcutta Stock Exchange have already given their no objection/no observation, no further service is required. The notice shall specify the next date of hearing of the petition, as aforesaid, and state that representation, if any, and if not already filed, should be filed before this Tribunal not later 7(seven) days before the next date of hearing of the petition and a copy of such representation should simultaneously be sent to the Advocate of the said Petitioner Company. If no such representation is received by the Tribunal within such period, it shall be presumed that such Authorities have no representation to make on the said Scheme. Such notice shall be sent in Form CAA 3 of the CAA Rules with necessary variations, incorporating the directions therein.
- The Petitioners to file an affidavit confirming compliance with the abovementioned directions of 10. this Tribunal, 3 (Three) days before the next date of hearing.
- The Petitioners may also file their rejoinder affidavits dealing with the objections/ observations, 11. if any, of the Authorities, 2 (Two) days before the next date of hearing.
- Urgent Certified copy of the order may be issued, if applied for, upon compliance with all the 12. requisite formalities.
